#### d) Philmont Purchases

- i) On behalf of the Philmont crew, Lynn required committee approval to purchase certain capital items for use by the Philmont crew and future High Adventure outing
- ii) The Committee agreed to allocate up to \$500 for these purchases
  - (1) 2 backpacking stoves @ \$140 each
  - (2) Stove service kit @ \$30
  - (3) 2 Platypus (water carrier) @ 40 each
  - (4) Water filtration system @ \$100
- iii) Jen (and the other QMs) will install a hasp and lock on the metal cabinet in the shed. Anything of value will be placed in this locked cabinet to make sure the items do not "disappear."
  - (1) Are we missing any "pocket rocket" stoves?
- iv) Lynn will maintain possession of the items until the cabinet is able to be locked.
